

LEED Pricing



LEED v4 and LEED v4.1

Registration fees are calculated and paid through the online registration process; receipt of payment determines the date of registration. The certification fee is based on your project's rating system and size; it is calculated and paid within LEED Online when the project team submits documentation for review. Project teams may prepay certification fees at any time. LEED Online reflects Canadian pricing (in Canadian Dollars) and member discounts. Registration and certification fees are not refundable and may change at any time. Fees for Credit Interpretation Requests (CIR) are not refundable and may change at any time.

Discounts for members

Member discounts for registration and certification are determined automatically based on the membership status of the individual processing the transaction. Member discounts on registration or certification fees apply to current Specialist members of the CaGBC.

LEED Canada

Registration fees were calculated and paid through the online registration process; receipt of payment determines the date of registration. The certification fee is based on your project's rating system and size; it is calculated and paid when the project team submits documentation for review. Certification fees should be calculated using the Certification fee submittal form, which must be completed and enclosed with payment. Registration and certification fees are not refundable and may change at any time. Fees for Credit Interpretation Requests (CIR) are not refundable and may change at any time.

Discounts for members

Member discounts for Registration were determined automatically based on the CaGBC membership status of the person registering the project online. To be eligible for member discounts on Certification fees, the organization that owns the building (or which occupies the space, in the case of commercial interiors) must be a current Specialist member of the CaGBC. The following exceptions apply:

- Public-private-partnerships (P3): the organization which owns the building or any organization that is a member of the P3 consortium responsible for financing of the project may qualify the project for member rates. Applies to Building Design and Construction rating systems.
- Managed and operated under contract: the organization which owns or is responsible for the ongoing management and operation of the building may qualify the project for member rates. Applied to Operations and Maintenance rating systems.

Discounts for governments and non-profits

Project buildings (or spaces, in the case of commercial interiors) that are owned by government and non-profit organizations, as well as all education and healthcare facilities, are eligible for a 10% discount on certification fees. The owner is defined as the organization holding title to the project building and recognized by law as having rights, responsibilities, and ultimate control over the building. The 10% discount is applied to the Specialist members or Advocate members and non-members rates stated below, as applicable.

All projects are subject to the Initial Stage Review fee, which includes both a Preliminary and Final Review with GBCI. Projects are only subject to a Subsequent Stage Review fee if they have previously successfully completed a stage of LEED ND certification and are returning for another round of review. For example, a project would pay the Initial Stage Review fee to submit a Plan Review and upon completion may pay the Subsequent Stage Review fee to submit a Built Project Review. For additional information on the available LEED ND review stages please refer to the Certification Guide.
