

LEED Pricing

Effective May 1, 2023



Registration fees are calculated and paid through the online registration process; receipt of payment determines the date of registration. The certification fee is based on your project's rating system and size; it is calculated and paid within LEED Online when the project team submits documentation for review. Project teams may prepay certification fees at any time. LEED Online reflects Canadian pricing (in Canadian Dollars) and member discounts. Fees are not refundable and may change at any time. Project size is determined by gross floor area (GFA).

Costs to expedite reviews are in addition to the certification costs and subject to the review team's availability. Expedited reviews reduce the review period from 25 business days to 12 business days.

Discounts for members

Member discounts for registration and certification are determined automatically based on the membership status of the individual processing the transaction. Member discounts on registration or certification fees apply to current Specialist members of the CAGBC.

All projects are subject to the Initial Stage Review fee, which includes both a Preliminary and Final Review. Projects are only subject to a Subsequent Stage Review fee if they have previously successfully completed a stage of LEED ND certification and are returning for another round of review. For example, a project would pay the Initial Stage Review fee to submit a Plan Review and upon completion may pay the Subsequent Stage Review fee to submit a Built Project Review. *In LEED v4, single family homes are detached homes and/or homes separated from adjoining units by vertical dividing walls, for example a side-by-side townhome. Units that are separated by horizontal dividing walls are considered multifamily low-rise buildings, for example a triplex with 3 units stacked above grade. In LEED v4.1, single family homes also includes multifamily buildings of up to four units, regardless of whether they are separated by horizontal dividing walls.

**A batch submittal is 2 or more homes submitted for certification at the same time, using the same project checklist and targeting the same credits.

However, fees for appeals and formal inquiries are assessed per group project, not per building or space within the group.
